

### City Manager Monthly Report for May 2022

Garrett Paving has completed this year's paving project which included Berry Street, Wells Street, and Dover Street.

We have been without one of our garbage trucks for several weeks due to mechanical issues. This has forced us to use a dump truck for a portion of the route. Because of this it has taken longer to run the route and we are only able to pick up bagged garbage. The repairs should be completed this week so we can get back to a normal schedule.

We hosted the Coosa-North Georgia Water Council meeting on May 18<sup>th</sup>. The Georgia Municipal Association was using the Community House for training, so we held the meeting in the courtroom. The people from this side of the state were very appreciative because normally we must drive to the west side of the state since most of the members are from there. Everyone commented on how great our building is.

The Cornelia Hospitality & Tourism Board put on their annual Music Festival on May 21<sup>st</sup>. The crowd was estimated at over 3,500, Neal McCoy even commented on how much larger the crowd was compared to when he performed in 2018! Thank you to the city employees and volunteers that make this event a success every year.

Evan Boyd with the help of some of his fellow Boy Scouts and volunteers from Carter & Sloope completed the planting project at the entrance to Chenocetah Tower. If you have not seen it, I advise you to do so as it looks great!

The Fire Department responded to 104 calls and completed 797 hours of training. Of these calls 38 were medical related, 24 public assists, 5 motor vehicle accidents, 7 fire alarms and 3 fires. The Fire Marshal completed 10 inspections, reviewed 2 sets of plans, issued 2 Certificates of Occupancy, and investigated 1 fire.

The Building Official issued 15 permits, with a total project value of \$2,297,646 and collected \$10,049 in permit fees. He completed 16 plan reviews, 21 commercial inspections, and 39 residential inspections.

The Police Department conducted 206 traffic stops, responded to 35 accidents, 7 fights, 19 shoplifting calls, and 36 alarms. They responded to a total 1,085 calls. The Investigative Division opened 14 new cases, closed 15, and made 4 arrests. Code Enforcement opened 54 new cases and closed 38 cases. The Probation Division collected \$2,904 in fines. They have 96 active cases, Community Service Workers completed 140 hours at a value of \$1,015.

The Wastewater Plant treated 74.7 million gallons of sewerage. The Water Plant treated 85.8 million gallons of drinking water. We recorded 1.8 inches of rain, the new reservoir level is at 26.1 feet and the old reservoir is 1 foot above full pool. We repaired 5 water leaks and 10 sewer blockages.

# City of Cornelia Public Works Monthly Report May , 2022

The sanitation route was completed weekly and roller carts were delivered when needed. The grass crew has been working on maintaining the route and city properties. We have been spraying weed killer on the R.O.W. The bush hog has been working on the street and sewer R.O.W. The brush pile at the recycling center was moved and burnt regularly. All city parks and downtown were checked and cleaned on a weekly basis. Work orders were completed as they came in. Trash was picked up on city streets and parks. We take turns coming in early every week to blow downtown, clean gutters, or check street lights. The chipper completed a route through the city. Street right-of-way was cut throughout the city and limbs cut back from signs where needed. We worked in the parks making repairs and doing routine maintenance. Pot holes were patched around the city as we found them. We set up and cleaned the Community House as needed. We worked around the shop organizing and cleaning. Equipment was checked and regular maintenance was done. We made repairs and did regular maintenance to city buildings as needed. Our landfill and chip/leaf piles were pushed off regularly. We fixed and replaced street signs around the city as needed. We have been working on the flowerbeds around town pulling weeds. We cleaned out the fountain at the Community House and made repairs to the pump and lines. We cut around the old reservoir and old dam. We got everything ready for, held, and cleaned up after the concert. Repairs were made to the bathrooms and trash can holders in Big City Park after it was


Rent Water & Sewer Fund comes out first month of each Qtr. Its at 50% at the 59% mark. Effects Oveall Budget %








May Septic Fees covered 70% of Landfill Tipping Fees



#### Water Production Quantities


- Water Produced in April of 2022 was 85.78 MG.

### Water Treatment Projects/Events


- Routine monthly sampling.
