  - a. Mural
    - i. Nick Morris We discussed possible funding for this project, grants, sponsorships, or the city helping fund the project. We will get with Nick in the next coming weeks about renderings.
  - b. Business and Amenities to serve residents
    - i. Work Plan reports Lindsey Fitzgerald discussed with the board that at the next planning retreat we should focus on some smaller projects that can be completed around downtown. - c. 2023 Summer Nights Bingo Fundraiser Lindsey Fitzgerald discussed with the board a possible fundraising idea at the 2023 Summer Nights Bingo. Board would be able to captivate the crowd from summer nights for bingo at the Depot. Board agreed this is a good opportunity. Lindsey Fitzgerald will work with Melissa Reeder to narrow dates for next year and present them to the board at a later date.
